1 Preamble

Recognizing the shared values of peace, love, and kindness that underpin all major religions, and with a commitment to uphold international law, the representatives of Israel and Palestine hereby agree to establish Abrahamia, and in concert with their neighbors Syria, Lebanon, and Jordan, to form the united states of Levantia, where Abrahamia is to be a state. This new political entity is envisioned as a beacon of unity, understanding, and shared prosperity, serving as an exemplar of cooperation and peaceful coexistence in the region.

2 I. Definitions:

Abrahamia: A unified sovereign state formed from the territories of Israel and Palestine.

Blessed Path: The principles of peace, love, kindness, and mutual respect derived from the teachings of major religions and global moral philosophies.

International Law: A collection of agreements, conventions, and treaties that govern relations between states.

3 Objective:

The primary objective of this treaty is to forge a long-lasting peace and establish a foundation for the united states of Levantia, starting with the creation of the state of Abrahamia from the territories of Israel and Palestine. This treaty acknowledges the historical challenges and root causes of conflict, such as overpopulation, environmental degradation, inequitable land distribution, human rights violations, and the perils of excessive nationalism and extremism. In addressing these issues, the new state of Abrahamia will be dedicated to upholding the Blessed Path, ensuring justice, equal rights, and opportunities for all its citizens, fostering an environment where ethnic, religious, and cultural diversity is not only respected but celebrated as a strength of the society.

4 Recognition of Challenges:

In the spirit of transparent governance and sustainable peace, this treaty recognizes the following root causes of conflict that must be addressed comprehensively:

- Overpopulation and its impact on resources and infrastructure.
- Environmental concerns, with a specific focus on reforestation and sustainable land management.
- The need for fair and equitable land distribution to prevent socio-economic disparities.

- The imperative of protecting and promoting human rights for all individuals.
- The necessity of making constitutional and legal frameworks publicly accessible to foster informed citizenry.
- The challenge of overcoming excessive nationalism and extremism through education and civic engagement.

These challenges are to be met with earnest efforts and innovative policies, with the united aim of transforming Levantia into a region characterized by peace, prosperity, and harmonious coexistence.

5 Obligations and Commitments

5.1 Adherence to the Blessed Path:

The state of Abrahamia, as part of the united states of Levantia, commits to embedding the principles of the Blessed Path into its fundamental governance structures and societal frameworks. The educational curriculum will be reformed to inculcate these principles from an early age, ensuring that they become an integral part of public life and contribute to a culture of peace, understanding, and harmonious coexistence among all its citizens. This commitment extends to addressing the root causes of historical conflict by promoting policies that mitigate overpopulation, encourage environmental restoration, ensure equitable land distribution, and foster a robust human rights culture.

5.2 Protection of Religious Freedom and Promotion of Interfaith Unity:

In Abrahamia, the inherent right to freedom of belief, worship, and expression will be unequivocally protected. The state will not only safeguard all places of worship but also actively promote interfaith dialogue and cultural exchanges to celebrate and integrate the diverse religious traditions of its people into the fabric of daily life. This promotion of interfaith unity is seen as an essential pillar in overcoming the divisions of the past and building a cohesive society in Levantia.

5.3 Upholding International Law and Addressing Societal Challenges:

As a testament to its dedication to peace and sustainable development, Abrahamia will adhere strictly to international law. This includes active cooperation with international organizations to ensure that domestic legislation upholds global human rights standards and contributes to the peaceful resolution of conflicts. Additionally, Abrahamia will implement innovative strategies to address the recognized challenges, such as creating public access to constitutional and legal information, combating the rise of nationalism and extremism through education, and ensuring the fair distribution of resources to all its people.

6 IV. Implementation and Verification

1. **Formation of an Independent Body:** An independent oversight body will be established with the mandate to monitor and ensure adherence to the Blessed Path and international law within Abrahamia. This body will be equipped with the necessary resources and authority to conduct assessments, investigations, and provide recommendations.
2. **Periodic Reporting:** To maintain transparency and accountability, periodic reports detailing the state's actions and compliance with the Blessed Path and international standards will be prepared. These reports will be submitted to the Abrahamian Parliament for review and subsequently made available to the public.

7 V. Dispute Resolution

1. **Interfaith Council:** An interfaith council will be established to mediate and resolve disputes arising from religious interpretations, ensuring that the diverse beliefs of Abrahamia's citizens are respected and harmoniously integrated.

2. **Arbitration Committee:** An arbitration committee will be set up to address and resolve disagreements based on international law, ensuring that Abrahamia maintains its commitment to global standards and norms.

8 Amendments and Modifications

Procedures will be put in place detailing how the constitution of Abrahamia can be amended. This will ensure adaptability to changing circumstances while steadfastly upholding its core values.

9 Duration

The commitment to the principles and values of Abrahamia is perpetual, reflecting the timeless and universal nature of the Blessed Path.

10 Ratification and Entry into Force

1. The constitution of Abrahamia will be subject to approval through referendums in both former territories.
2. Following ratification, a transitional government will be constituted to oversee and guide the formation of Abrahamia.

11 International Relations

1. Abrahamia will actively seek peaceful and constructive relations with all nations, with guidance from the principles of the Blessed Path and the norms of international law.
2. The nation commits to active participation in global forums that champion peace, mutual understanding, and collaboration.

12 Final Clauses

1. The official languages of Abrahamia will be declared, ensuring inclusivity and clear communication.
2. Detailed provisions will be made concerning the depositing of the original constitution.
3. Clauses will be introduced outlining the provisions and processes for regions or territories that express a desire to join Abrahamia in the future.

A Annexes

1. A compilation of texts from major religious scriptures will be included, all emphasizing the principles of the Blessed Path.
2. A list of key international laws and conventions that Abrahamia pledges allegiance to will be provided, ensuring its commitment to global peace and justice.
