Latin Motto: Tam arte quam marte Motto Translation: As much by art as strength.

The likely ancestral tongue was Scottish Gaelic, which is a Celtic Indo-European language.

## 2 Milne Badge

closely related clan to the Milne's that has a clan badge (MacIntyre) uses Scottish Heather (Calluna vulgaris), so can also be used, though anything in the heather family could do. Heaths however do prefer acidic soil, and in Grey County it is usually alkaline, so would

Scottish clans traditionally wore a particular plant as emblematic of their clan. The milnes do not have an official plant, though most appropriate could be a stalk of wheat. The most

need to be supplemented by peat.

Primrose being an example of an Ericales relative that can handle alkaline soil. The clan colours are blue and yellow, so a blue and yellow primrose variety should fit.

### 3 Milne Family Name History

The Milne's first appeared on the historical record in Roxburghshire, Scotland, as early as the 12 century CE.

Milne means miller, referring to the milling of grain, which since Roman times in Europe always had close ties to both the government and the church. The governments found

always had close ties to both the government and the church. The governments found that it was difficult to tax forest dwellers or "savages" as they were called, so ordered the hazelnuts, chestnuts and other edible shrubs and trees cut down, and ordered the growing

of cereal grains because it was easier to see how much was grown, and thus how much the tax collector should expect at harvest time. Wheat in particular is a grain that can not easily be consumed without milling, and is necessary for various sacred rites of the Christian

Church that call for leavned bread. Forcing farmers to grow wheat meant they were likewise forced to bring their grain to the mill, where the miller would take a percentage, much of which would go to the local government as taxation in kind. In protest many of the people of the British Isles would grow barley, which can be effectively processed at home into

a porridge, overstood porridge would ferment and be turned into beer, which is why it is believed that the British Isles were the heaviest beer drinkers in Europe, possibly until the present. The close ties to the government and the church, as well as effectively being tax collectors did give them a stable place to be, and so they had many children. Food forests

are of course much more sustainable, easier and allow people to live longer. Perhaps you will play a part in restoring them.

One of the first famous Milnes include: Walter Milne (died April 1558), the last Protestant martyr to be burned at the stake for heresy in Scotland; John Mylne of Perth (c.

1585-1657), Scottish master mason, Master Mason to the Crown of Scotland.

The first Milne in Canada was Mr. Alexander Milne U.E. who settled in Saint John,

New Brunswick c. 1784.
Ross Milne of Grey County was perhaps Canada's first Milne to become a Member of Canadian Parliament.

### 4 Milne Geneology

While the Y-DNA is only between 2-0.2% of your genome, it is also everything that makes you male. The Milne family has been identified as having the Y-DNA haplogroup of R1b or more specifically R-A13318 <sup>23</sup>.

animals. When sick or injured they would go to lay encased in a swamp or bog until they felt well again. Within the last 1,500 years or at around 500CE, you share a paternal relative with people who now have patrilineal names including: Greig, McIntyre, Hadden, MacFarlane, MacKinley of the British Isles, Smed, Turner of Denmark, and Griffin of Italy, and Walker,

Cowan of the USA.<sup>4</sup> Greig you may have had a common ancestor within the last several

centuries.

Before the arrival of the Romans as all people of the British Isles your ancestors lived an indigenous way of life subsiting mostly on hazelnuts, fruits, tubers suplemented by game

Within the last 4,800 years or at around 2,800 BCE your paternal ancestors lived in

Western Continental Europe and where they branched of from (R-U106) what is now the House of Bourbon that were the kings of France, and the House of Wettin who have been kings of UK, Belgium, Sweden, Poland, Bulgaria, Portugal, and Saxony. Within the last 25,000 years your paternal ancestors lived in the Caucauses (Geor-

gia/Armenia) where they branched off from most South West Europeans (R1b) and Eastern Europeans (R1a) such as the Yamnaya culture that brought Indo-European languages to the world, and established Indo-Aryan high castes in India, as well as the Kazarian and

Ottoman Empires. Within the last 38,000 years your paternal ancestor (P) lived in the Altai/Tuva or Gobi desert region where they branched off from the majority of Indigenous Americans, including those of both North and South America, who are mostly of the Q and R1b haplogroups. Within the last 50,000 years our paternal ancestor (K-M9) lived in India along the

Himalayan Foothills or Ganges Basin, where they branched off from the majority of Eurasian haplogroups, such as the East Asians (O) like the Han and Ming Dynasty, North Asians (N) such as the Zhou, Rurikid Dynasty and the Finnish, as well as Middle Eastern or Persian (L) such as Sayyid Ajjal and North African (T) Thomas Jefferson.

Within the last 60,000 years our paternal ancestor (F-M89) lived in the Indus Valley where they branched off from Ancient Europeans and Georgians (G) such as Joseph Stalin and King Richard III of England, Northern Europeans (I) such as Birger Jarl and the House of Hohenzollern (Kings of Prussia), Indians (H) and those who became the royal Jews (J)

including King David, Jesus, the Prophet Mohammad and the Rothschilds.

Within the last 75,000 years our paternal ancestor (CF) lived at the Strait of Hormuz near the Horn of Africa, where your ancestors branched off from North East Asians (C), many of whom also colonized North America, particularly the Na-Dene people of North Western Canada, and produced such notables as Genghis Khan.

Within the last 100,000 years our paternal ancestor (CT) lived in North East Africa where they split off from North Africans (E) such as Ramsses III of Egypt, Napolean and

Canaanite Jewish (E-M35) such as Albert Einstein and Hitler, as well as Central East Asians (D) such as indigenous Tibetans and the Emperors of Japan. And within the last 300,000 years our paternal ancestor lived in West Africa (A) known as Y-DNA Adam that is in common with all extant homo sapien males, including Barrack Obama, recent president of the USA.

Within the last 700,000 years we have an ancestor that was in common with the Neanderthals and Denisovians whose DNA fragments still resides in most modern people, it is said we received DNA from the peoples of Mars and Maldek which had destroyed each
